For its Closing Conference, the ESF research networking programme « Public Goods, Public Projects, Externalities » (PGPPE) is organizing, in the framework of and inside the PET10 Conference, a three days, non-stop, special PGPPE session which will be closed with a round


table on the theme "Public Goods and Public Policy Analysis - . State of art and new issues".



A special room will be dedicated to the PGPPE session for the duration of the Conference. The timing of the session will be the same as in all other sessions of PET10. The time for presentation and discussion for each paper will thus be shorter than in the previous PGPPE workshops. In counterpart, this will allow to accept until to 32 papers. The presenters and their co-authors will benefit of financial conditions comparable to ones in the previous PGPPE scientific events. Their PET10 registration fee will be paid by the programme and, depending on the amount of available funds, they will be subsidized for their accommodation expenses.

Submitted papers should be in one of the non-limitative list of research directions encouraged by the programme:

- * Public goods and public policy: Competition, Regulation, Incentives, Governance
- * Lindahlian approaches to equilibrium and optimality
- * Regulation of the production of public goods
- * Public goods, redistribution, taxation and tax competition
- * Public goods, public policy and growth
- * Local public goods and multi-jurisdictional economies
- * Externalities and sub-optimality of equilibrium
- * Environment
- * Effects of tradable emission permits
- * Historical and political economy approaches.



Simultaneously with their submission on the web site of the PET10 Conference, papers should be sent by mail to Unal Zenginobuz (zenginob@boun.edu.tr) and Monique Florenzano (Monique.florenzano@univ-paris1.fr), program chairs for the PGPPE session. Participants to the PGPPE session will be selected by a Scientific Committee composed of the Steering Committee and the scientific advisers of the Programme.
