**2003 EUROPEAN MEETING OF THE ECONOMETRIC SOCIETY ANNOUNCEMENT AND CALL FOR PAPERS** The 2003 European Meeting of the Econometric Society will take place on the campus of Stockholm University, Stockholm, Sweden, from August 20 to August 24. For the first time, the EEA Annual Congress and the Econometric Society European Meeting (EEA-ESEM) will run in parallel at the same place. Registering for either the Congress or the Meeting, participants will be eligible to attend all sessions of both. Economists, including those who are currently not members of the Econometric Society, are invited to submit papers in Theory and Applied Economics and in Econometrics and Empirical Economics for presentation at the Meeting. The Program Committee Chairs are Professor Bernard Salanié, INSEE-CREST, Paris, for Theoretical and Applied Economics, and Professor Richard J. Smith, University of Bristol, for Econometrics and Empirical Economics. Each author may submit only one paper to the ESEM. The same paper may not be submitted to both the ESEM and the EEA Congress. Submissions can be made from December 1, 2002 the deadline is February 15, 2003. Papers can only be submitted electronically through the EEA-ESEM 2003 web site at [www.eea-esem2003.org](http://www.eea-esem2003.org). They must consist of a single PDF file with a maximum size of 2MB. No other format will be accepted. Information links on the creation of PDF files will be available on the web site, which will be operational as of November 1, 2002. Authors will be notified regarding acceptance or rejection by April 15, 2003. Authors presenting papers must have registered by June 18, 2003. The only means of registering is through the EEA-ESEM 2003 web site at [www.eea-esem2003.org](http://www.eea-esem2003.org). The web site will open for registration on November 1, 2002, and the last day for early registration ( at a reduced fee ) is June 4, 2003. Reservations of rooms at a variety of hotels and hostels can also be made through the EEA-ESEM web site at [www.eea-esem2003.org](http://www.eea-esem2003.org). The deadline for guaranteed accommodation is June 18, 2003. No financial aid will be available. A committee chaired by Professor Tore Ellingsen, Stockholm School of Economics, and Professor Harry Flam, IIES, Stockholm University, is responsible for the local arrangements. They will be assisted by Christina Lönnblad, IIES, Stockholm University.
