The topic of the Conference will be on: "Economic and Financial Issues in an Enlarged Europe" The Conference will focus on the changes we observe in the global economy and on the European Integration process. Papers are solicited in such areas as: European Integration World Integration Analysis of Financial Markets Economic Geography Spatial Economics International Monetary Economics International Trade and General Equilibrium Macroeconomic Issues and Policy Growth and Development Regional Economics And Policy Industrial Economics and Organisation Labour Economics Factor Mobility New Political Economy Public Economics Topics On The Dotcom/Digital Economy. It is envisaged that a number of papers from this Conference will be published in special issues of established journals in the forthcoming months. Paper Submission Abstracts, papers and/or session proposals should be submitted to the local organizer Dr. Elias Soukiazis as attached files (doc or pdf format) to the following address: elias@fe.uc.pt Papers relating to theoretical, empirical and policy issues are welcome until March 31st, 2005. Papers submitted must include an abstract that should not exceed 200 words, and should contain JEL classification codes. The authors' full name, affiliation, address, phone/fax, and e-mail for correspondence should also be indicated. Proposals for complete sessions are encouraged. Each session should be made up of three papers. In the submitted proposals, session organizers should indicate the name of the session chair, the names, affiliations, contact numbers and e-mail addresses of the authors and the chair, the titles of the papers each accompanied by the paper abstract. Participants are expected to serve as program chair at Conference sessions. Authors are expected to send an electronic copy of the final version of their paper by the end of April 2005 in order to facilitate its reproduction for the relevant session. After that date it is the responsibility of the authors to bring enough copies to the session. This address is already available. The Conference fee will be Euro150 this includes some lunches and dinners.
