The XVII European Workshop on General Equilibrium is being organized by the Department of Economics and Statistics (DISES), University of Salerno, Italy. The workshop will take place on June 13-15, 2008, in Paestum (30 km south of Salerno) at Ariston Hotel-Congress Center. Paestum is a very impressive and famous archaeological site by the sea. Moreover, it is only 1 hour drive from the Amalfi Coast. The European Workshop on General Equilibrium allows participants to present and be informed of the latest developments in general equilibrium theory and its applications as well as on neighbouring fields. The workshop encourages young researchers to present their work, and senior theorists typically attend the workshop. Funds are available to cover speakers' accommodation expenses. Participation in the workshop is not limited to researchers based in Europe. This year, the event will include the 4th Debreu Lecture and the Lecture on Economic Theory promoted by the Centre for Studies in Economics and Finance (CSEF). Attendees desiring to present a paper at the Workshop are invited to submit a copy of their paper. Submissions should be made electronically, as a PDF file to [ge-europe08@unisa.it](mailto:ge-europe08@unisa.it). Attendees are strongly invited to mention explicitly in the object of their submission one or two of the following areas: Public Economic Theory, Financial Markets, Game Theory, Economics of Information, Decision Theory, Contract Theory, Microeconomic Theory, Macroeconomic and Monetary Theory. Submitted papers must include a short abstract, along with the correspondent author's e-mail address and phone number. Papers should be submitted as soon as possible; the submission deadline is MARCH 20, 2008. The notification of acceptance will be sent to contributors before APRIL 20, 2008.
